2 request findings of fact and conclusions of law, to appeal, and to move for a new trial.

6 **NOW THEREFORE, IT IS HEREBY ORDERED** that the bonds of matrimony now
7 existing between the parties are hereby wholly dissolved, and an absolute Decree of Divorce is
8 hereby granted to the parties, and each of the parties are hereby restored to the status of a single,
9 unmarried person.
