


**DESIGNATING PANEL OF**  
**SUBSTITUTE JUSTICE'S OF THE**  
**PEACE AND PROVIDING FOR**

14 It appearing to the Board that NRS 4.032 imposes a duty upon the Board of County  
15 Commissioners, for Churchill County, Nevada, to select a number of persons it determines appropriate  
16 to comprise a panel of substitute justice's of the peace; that any member of the panel may be selected by  
17 the justice of the peace to replace him whenever he is disqualified from acting in a case pending in  
18 justice's court or he is unable to perform his official duties because of his temporary sickness or absence,  
19 or other cause.

20 It further appearing to the Board that in any instance where a justice of the peace is disqualified  
21 from acting in a case pending in the justice's court or he is unable to perform his official duties because  
22 of his temporary sickness or absence, or other cause, the justice of the peace shall appoint a person from  
23 the panel of substitute justice's of the peace, or pursuant to NRS 4.340, invite another justice of the peace  
24 to act in his place.

25 It further appearing that if the appointment of the justice of the peace pro tempore becomes  
26 necessary and the justice of the peace fails or is unable to appoint a person from the panel of substitute  
27 justices of the peace, the Chairman of the Board shall appoint a person from the list of substitute justice's  
28 of the peace or a municipal court judge to act in his place.

**IT IS HEREBY FURTHER ORDERED** that all persons appointed from the panel of substitute justice's of the peace herein created must take and subscribe to the official oath before acting as a justice of the peace pro tempore.

**IT IS HEREBY FURTHER ORDERED** that any person acting as a justice of the peace pro tempore be and the same is entitled to receive a per diem salary as provided for by NRS 4.040.
