Recommended Board Action: I move to disburse the sum of \$8,250.00 to the Lahontan Valley Environmental Alliance for the third quarter 2007-2008.



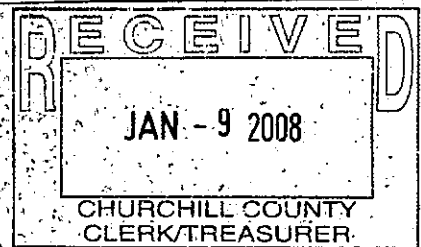
